### Notes

**Application fee:** a R435 non-refundable administration processing fee is payable upon application.

**Registration fee:** a R3 600-00 non-refundable placement fee is payable to the school upon acceptance of the pupil.

**Advance payment discounts:** 3% discount on annual payments, provided payment is received during the month of January.

**Sibling discount:** 10% First sibling (second child); 5% for the second sibling (third child).

**Monthly due date:** Fees are paid monthly by the 7<sup>th</sup> of the month. Late payments will incur a penalty fee of **R160**.

**Payment method:** Fees are payable in advance via Debt order, Stop order or annually in advance.

**Reference:** Please make sure to use your child's full name as reference to make sure payments are allocated correctly.

**Monthly sundry charges are non-refundable** and tailored for each class include the following:

- Food levy (Kindergarten)
- Main lesson workbooks and general stationery
- Chair bag, Crayon holder and Recorder (Class 1)
- Class camp (from class 3 to 7): One compulsory camp a year.
- Class 5 weekly drumming lessons: R35 per child per lesson
- Class 6 and 7 weekly Poi lessons: R35 per child per lesson
- Class 7: Poi set
- Sports & Movement (Class 1 to 7): R212 per term
- Extra Mural: One Compulsory extra mural
- Spring Fair Levy: R280 per annum
- Stationery, Craft & Handwork: Class specific
- Class photo
- Class fund: R50

**Non-payment procedure:** The school will notify Parents / Guardian should their account be older than 30 days. Fees not settled within 60 days then Parents / Guardian will enter into an Acknowledgment Debt Agreement. Any payment defaults on the Acknowledgment of Debt Agreement will result in Parents/Guardians to be requested to immediately remove the children from school. (Only in exceptional circumstances, and at the discretion of the Board of Trustees and Finance Mandate Group, will a pupil be allowed to enter a new term if any portion of the fees of the previous month/term or year is unpaid). The account will be handed over to attorneys of which Parents/Guardians will be liable to settle any incurred cost.

**Intention to Withdrawal:** A full term's notice, in writing, before the withdrawal of the child from the school, is required. Alternatively, three month's fees in lieu of notice will be payable. This is applicable regardless of the reasons for such withdrawal.

**Participation:** You would be expected to regularly attend Class Parent meetings, Parent talks, the Annual General Meeting and Festivals, as well as Parent Enrichment programs in Waldorf Education, which parents are asked to attend if they have not previously done so, in order that our methods and expectations can be explained and supported. All families are expected to play an active part in fundraising events, as we are an independent, fee-dependent school. Parents are held responsible for supporting our school's ethos, expectations, and requirements.
